We would like to draw your attention to the ITB 14.6 page 29 of bidding document which asks a bidder to submit its bid for 100% items and quantities of each lot. In this regard NTDC has asked 2000A and 3150 A disconnect switch for 132/145 kV in LOT III. We would like to request to separate item 1.1 (145 kV Bus Disconnect 3150A) in LOT III from rest of the Disconnect switch in same lot which are of 2000 A.</p> <p>Please also note that in recent past across the discos and even in NTDC tenders, usually 2000 A disconnect switch for 132/145 kV system have been asked for and type testing has been done accordingly. As per our information no bidder/ manufacturer has supplied 3150 Amp disconnect switch to Pakistan/ Discos for 132/</p>	The said breaker is required for Bus Coupler. Bidder is advised to follow the tender document.
